SPECIMEN CONDITIONS TO BONDS

1. AIR FREIGHT LICENSEE.
“ in his/her capacity as a person licensed as an Air Freight Licensee under section 10 of the Customs and Excise Act, complies in all respects with the provision of the said Act and of any subsidiary legislation made thereunder in respect of all goods imported as air freight in any aircraft owned or operated by him or for which he is the lawful agent”
2. BONDED WAREHOUSE
“ in his/her capacity as the licensee of the Bonded Warehouse situated at and known as complies with the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder in respect of Bonded Warehouses and to goods stored therein or entered for removal to or from bonded warehouses and, further complies with such conditions as the Commissioner General may from time to time, lawfully impose in relation to the said bonded warehouse”
3. CUSTOMS AGENT
“ in his/her capacity as a licensed Customs agent duly complies, to the satisfaction of the Commissioner General, with the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder,”
4. EXCISE MANUFACTURER
“ in his capacity as a person to whom a licence has been issued to manufacture and store at his premises situated at Certain excisable goods, namely, complies with all the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder in respect of such goods.....”
5. LICENSED PRIVATE SIDING
“in his/her capacity as the licensee of the private siding situated at Complies with all the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder in respect of goods subject to customs control delivered to such private siding.....”
6. MANUFACTURER UNDER REBATE
“ complies with all the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder in respect of goods entered at a reduced rate of duty for use by him in manufacturer in Malawi and duly accounts for such goods to the satisfaction of the Commissioner General.....”
7. REMOVAL AND STORAGE OF GOODS SUBJECT TO CUSTOMS CONTROL
“ In respect of such goods subject to customs control as he may from time to time be allowed to remove from one place in Malawi to another place in Malawi, duly proceeds direct, without interfering with or offloading such goods, to such place and there produces such goods intact to the proper officer at such place as may be approved by the Commissioner General and within such period as may be allowed and retains the goods intact at that place until they are released by the proper officer”
8. SUBMISSION OF DECLARATION OF GOODS RELEASED WITHOUT ENTRY
“ submits the declaration for goods of which he has taken delivery without entry under section 33 (b) of the Customs and Excise Act within 48 hours of the time of such delivery or within such further period as the Commissioner General may allow.....”
9. SURTAX
“ In his/her capacity as a person registered for Surtax, complies with all the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder in respect of Surtax,.....”
10. TEMPORARY IMPORTATION
“ re-exports, in accordance with the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder, within such period as the Commissioner General may allow such goods as he may from time to time be allowed to enter for temporary importation or otherwise accounts for such goods to the satisfaction of the Commissioner General.....”
11. TRANSIT.
“re-exports, in accordance with the provisions of the Customs and Excise Act and of any subsidiary legislation made thereunder, within such period as the proper officer may allow each and every consignment of such goods as he may from time to time enter for transit through Malawi and proves such re-exportation to the satisfaction of the proper officer.....”
